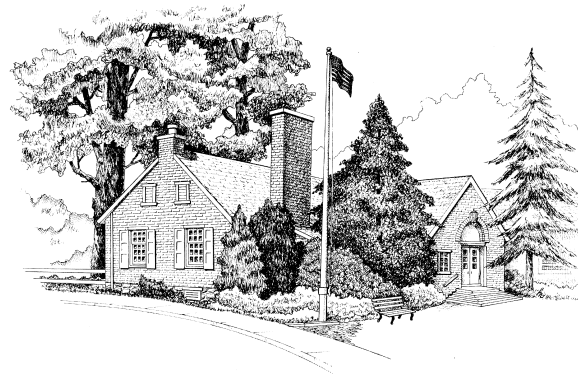

Announcing Our \$5000 Refer a Student Tuition Rebate!

Word of mouth from our current families is clearly the strongest marketing tool available to WFS today. Your referrals help us grow enrollment and maintain the unique educational environment that you value so highly for your own children.

As a thank you for your efforts to bring new families to our school, we are pleased to offer a major referral incentive in the way of a \$5,000 tuition rebate for your family.

The more quality students we have the better off we will be, from a cost of tuition to program perspective. For every student you refer to WFS who is offered admission and enrolls, you will receive the tuition rebate spread out over four years and payable in May of each enrolled year. (Year 1: \$500, Year 2: \$1500, Year 3: \$1500, Year 4: \$1500).



FAQs

How do I notify the school of a referral?

Simply detach and fill out the back panel of this brochure as soon as you have recommended us to a family. Drop it off at the Main Office for processing.

How is the \$5000 discount applied?

The first month of May the referred student is an enrolled and active student, a \$500 rebate will be given to the referring family. Each May for the next three years that the referred student is enrolled AND the referring family is enrolled, a \$1500 rebate will be given to the referring family.

How many referrals can I make? And if they enroll, how many discounts can I get?

As many as you like—there is no limit on the number of referrals you can make or how many corresponding rebates you will receive.

Are there any tax implications?

Yes. Referral incentives would be considered 'income' and therefore, annually the referring individual will be required to provide a W-4 and direct deposit banking information. Please contact the Director of Finance & Operations for more details.

What happens to the rebate if either the referrer or referral ends his or her enrollment?

The rebate remains intact for the full four years as long as the referred student is enrolled for four years AND the referrer is the parent of an enrolled student for those same four years. If either the referrer or the referred leaves before the four year period is over, the rebate ends. No additional rebate checks will be issued even if the referring family has not been able to take advantage of all four years of the incentive rebate.
